Tax technical support is provided in response to questions you, or other people you designate within your organization, send to COKALA. E-mail is the standard means through which we will reply to your queries, because it preserves the information that was exchanged, and permits the attachment of supporting documents where needed. Same-day response to e-mail queries is our standard, or next business day in some instances. You can also reach us by phone, if needed. The service covers payments that may be tax reportable on Form 1099, Form W-2, and Form 1042-S.

The subscription service is generally limited to questions for which tax technical responses can be provided in less than 30 minutes. If at any time we perceive that a question will require more extensive research and analysis of specific factual situations, we will advise you prior to beginning work on that question, in order to discuss whether you prefer to have the query handled on a project basis or to have us limit our response.
